## WHAT SHOULD I DO IF I AM WORRIED ABOUT A CHILD?

If whilst working with a child you become concerned about:

- Comments made by a child
- · Marks or bruising on a child
- Changes in the child's behaviour or demeanour

Please report these concerns to one of the safeguarding team or Designated Safeguarding Lead (DSL).

The office will assist you with finding and liaising with one of the safeguarding team immediately.

Brymore Academy has a Safeguarding Policy and a Code of Conduct, a copy of this is available on our website.

# WHAT SHOULD I DO IF THE ALLEGED ABUSER IS A MEMBER OF THE SCHOOL STAFF?

You should report the allegations to the Headteacher, Mr M Thomas or call Trust Safeguarding Lead, Mrs Sally Power on 07867976901.

# WHAT SHOULD I DO IF A CHILD DISCLOSES THAT HE IS BEING HARMED?

Immediately record details of the disclosure, including wherever possible the exact words or phrases used by the child. Forms for the

recording concerns (cause for concern forms) are available in reception and should be completed and handed in person to a Designated Senior Lead (DSL) so that the information can be discussed immediately. Following this discussion the DSL will ensure that the matter is dealt with in the most appropriate way.

Please ensure that you have signed and dated the form.

# WHAT SHOULD I DO IF THE ALLEGED ABUSER IS THE HEADTEACHER?

You should report the allegations to the Trust Safeguarding Lead, Mrs Sally Power who will notify the Chair of Governors. You can also report your concern directly to the CEO Mr Peter Elliot

## HOW DO I ASSURE MY BEHAVIOUR IS ALWAYS APPROPRIATE?

Appropriate relationships with children should be based on mutual trust and respect.

Do not photograph children, unless requested by a member of staff, exchange emails or text messages, or give out your own personal details.
